1) COMPONENTS:

Odorless Mineral Spirit, Alkyd Resin, and additives

2) HAZARDOUS COMPONENTS:

ODORLESS MINERAL SPIRIT:

CHEMICAL NAME: NAPHTA (PETROLEUM), HEAVY ALKYLATE

CHEMICAL FAMILY: HYDROCARBON SOLVENT

3) HEALTH INFORMATION:**EYE CONTACT:** Liquid may be eye irritant.**SKIN CONTACT:** Liquid is moderately irritating to the skin. Prolonged or repeating liquid contact can result in defatting and drying of the skin which may result in skin irritation and dermatitis.**INHALATION:** High vapor concentrations may result in central nervous system depression.**INGESTION:** Ingestion of product may result in vomiting; Aspiration (breathing) of vomitus into the lungs must be avoided as even small quantities may result in aspiration pneumonitis.**SIGNS AND SYMPTOMS:** Mild irritation as noted above. Do not spray apply. Avoid prolonged contact with skin. Wash hands immediately after use.

5) EMERGENCY AND FIRST AID PROCEDURES:**EYE CONTACT:** Flush eyes with water. INGESTION: Do not induce vomiting. If vomiting occurs spontaneously, keep head below hips to prevent aspiration of liquid into the lungs. Get medical attention.

NOTE TO PHYSICIAN: If more than 2.0 ML per Kg. has been ingested and vomiting has not occurred, emesis should be induced with supervision. Keep victim's head below hips to prevent aspiration. If symptoms such as loss of GAG reflex, convulsions or unconsciousness occur before emesis, gastric lavage using a cuffed endotracheal tube should be considered.

FLASH POINT AND METHOD: 125 Deg. F (TCC)

EXTINGUISHING MEDIA: Use water fog, foam, dry chemical or CO₂. Do not use a direct stream of water. Product will float and can reignited on surface of water.
